Express Assumption of Risk, Complete Waiver and Agreement Not To Sue And Indemnity Agreement

READ THIS AGREEMENT CAREFULLY

This Express Assumption of Risk, Complete Waiver and Agreement Not to Sue and Indemnity Agreement, is made by ("Camper or Volunteer") _____ if Camper/Volunteer is 18 years of age or older for himself, his agents, partners, associates, successors, heirs, assigns, representatives, attorneys, and all persons acting by, through, under, or in concert with Camper/Volunteer (and is made by the undersigned parent or legal guardian ("Parent(s)") of Camper/Volunteer for and on behalf of Camper/Volunteer if Camper/Volunteer is not 18 years of age or older) in favor of San Diego Christian Foundation, Inc., its past and present members, volunteers, agents, partners, associates, affiliates, directors, officers, employees, predecessors, successors, heirs, assigns, representatives, attorneys, and all persons acting by, through, under, or in concert with it (collectively, "SDCF").

Camper/Volunteer wishes to (and if under 18 years of age also the Parent(s) authorize and grant permission to allow Camper/Volunteer to) participate in the Mt. Palomar Bible Camp ("Bible Camp") to be provided by SDCF.

In consideration for being accepted by SDCF for participation in Bible Camp to be provided by SDCF, the undersigned Camper/Volunteer and Parent(s):

1. UNDERSTAND AND ACKNOWLEDGE THAT TRAVEL TO AND FROM BIBLE CAMP AND ACTIVITIES AT BIBLE CAMP MAY BE DANGEROUS AND POSE THE POTENTIAL RISK OF PROPERTY DAMAGE, SICKNESS, BODILY INJURY AND DEATH TO ALL INDIVIDUALS WHO PARTICIPATE.
2. ASSUME ANY AND ALL RISKS, LIABILITY AND RESPONSIBILITY involved in or arising from Camper's/Volunteers travel to and from Bible Camp and Camper's/Volunteers participation in Bible Camp and all activities at Bible Camp including without limitation the risks of property damage, sickness, bodily injury or death resulting from the foregoing, whether or not caused by the negligence or other fault of SDCF.
3. Release, agree to indemnify and hold harmless from and agree not to sue SDCF on account of or in connection with any and all claims, liabilities, demands, obligations, causes of action, damages, losses, costs and expenses, including without limitation attorney's fees, of any nature whatsoever, known or unknown, fixed or contingent, whether or not caused by the negligence or other fault of SDCF; including, without limitation, any and all claims arising out of or connected with any property damage, sickness, bodily injury or death, as well any and all expenses of any nature whatsoever which may be incurred or sustained by Camper/Volunteer while traveling to and from the site for Bible Camp, during or in connection with Bible Camp in any way, and during Camper's/Volunteers participation in any and all activities associated with Bible Camp, and any claim arising out of strict product liability or any other liability without fault and further release, agree to indemnify and hold harmless SDCF against loss from any future claims, demands, damages and rights or actions not known to either party hereto, or which may later develop or be discovered and that may subsequently be brought by Camper/Volunteer or by any other person or persons on account of any property damage, sickness, bodily injury or death which may be incurred or sustained by Camper/Volunteer during or in connection with the foregoing and further agree to reimburse and make good to SDCF any loss, damages or costs SDCF may have to pay as a result of any such action, claim or demand.
4. Waive the protection afforded by any statute or law in any jurisdiction (e.g., California Civil Code § 1542) whose purpose, substance and/or effect is to provide that a general release shall not extend to claims, material or otherwise, which the person giving the release does not know or suspect to exist at the time of executing the release.
5. Agree to pay for any and all injuries and damages caused by Camper/Volunteer, negligently, willfully, or otherwise to Camper/Volunteer, to any other person, to SDCF and to any property.

If this box is not checked, Camper/Volunteer and Parents understand that SDCF from time to time produces promotional material relating to its programs and that Camper/Volunteer may be included in videotapes or photographs taken during Bible Camp so, without reservation or limitations, hereby assign, transfer and grant to SDCF, its successors and assigns, licensees, sponsors and all other commercial exhibitors the exclusive right to photograph and/or videotape Camper/Volunteer and to utilize such videotapes and photographs and Camper's/Volunteers name, face, likeness, voice and appearance as part of Bible Camp, in advertising and promoting similar future events. If this box is checked, Camper/Volunteer and Parents do not make such assignment or grant such rights.

I understand that SDCF is relying on this Agreement to accept Camper/Volunteer for participation in Bible Camp and would not accept Camper/Volunteer in Bible Camp if Camper/Volunteer did not execute this Agreement.

We have read and understand this Agreement. We understand that by signing this Agreement, we surrender valuable rights. We do so freely and voluntarily. We further certify that we have received and read a copy of this Agreement.

GENERAL RELEASE AND WAIVER

The undersigned has asked Palomar Christian Conference Center (hereinafter "PCCC") to allow the individual named above, sometimes referred to herein as the "participant," to participate in the activities offered at PCCC. Activities may include, but are not limited to, Archery, Rifles/Shotguns/BB Guns, Paintball, Horseback Riding, Swimming, Zipline, and Challenge Course. If the participant named above is a minor, the undersigned hereby authorizes PCCC to allow said minor to participate in all activities offered by PCCC to participants of the group's event. The undersigned (a) acknowledges that the activity involves physical exertion and other risks; (b) is aware of the possibility of risk of injury to individuals participating in or observing the activities; (c) is aware that such risk of injury includes, but is not limited to, risk of permanent disability, blindness, loss of hearing, or death; (d) recognizes the need for each participant to follow all rules and directions given by any Staff Member, Wrangler, Range Master, Game Coordinator, or Referee; (e) understands that each participant shall be required to wear any safety gear deemed necessary by PCCC and that it is the responsibility of each participant to do so; (f) warrants that the physical and mental condition of the participant will enable him/her to participate safely in each of the activities listed above; (g) authorizes PCCC to furnish a firearm for the purpose of instructing the participant in the safe handling of firearms and safe shooting and/or allowing the participant to utilize said firearm at PCCC's gun range; (h) understands and acknowledges that a horse, regardless of its training and usual past behavior and characteristics, may act or react unpredictably at times based upon instinct or fright, and that this is an inherent risk assumed by the participant; and (i) understands and acknowledges that other risks to which the participant may be exposed include, but are not limited to, snake bite, insect bites and stings, exposure to poisonous plants, as well as risks associated with traveling along mountain roads and inclement weather.

The undersigned, individually and on behalf of any minor participant named above, hereby waives and releases PCCC and its officers, directors, employees, agents, and insurers, and each of them, from any and all claims, demands, actions, causes of action and rights, (contingent, accrued, inchoate, or otherwise), which may arise out of, or in connection with, the participant's attendance at the above-referenced event and/or any activity engaged in by the participant while attending the event, whether such claim is based upon PCCC's active or passive negligence or otherwise.

In addition, the undersigned agrees to defend and hold PCCC harmless from and against any and all claims, liabilities, expenses, damages, losses, causes of action, and suits (including, without limitation, attorneys' fees and costs) arising out of, or any way related to, the participant's attendance at the above-referenced event and/or any activity engaged in by the participant while attending the event, whether such claim is based upon PCCC's active or passive negligence or otherwise.

IMAGE RELEASE AND WAIVER

The undersigned hereby gives permission to PCCC to use any photographs, videos, and/or audio recordings of the participant for promotional materials, including the PCCC web site postings, without expectation of compensation, including, but not limited to, any royalties, proceeds, and/or other benefits derived from such photographs, videos, or audio recordings.

MEDICAL RELEASE AND WAIVER

The undersigned hereby acknowledges that PCCC does not provide medical personnel and agrees that the undersigned shall be responsible for (a) providing any emergency transportation required by the participant named above, and (b) paying any medical and hospitalization costs incurred while attending the event.

REPRESENTATION AND WARRANTY OF AUTHORITY

By signing this General Release and Waiver of Rights, the undersigned represents and warrants to PCCC that he/she is of legal age and competence to give a valid release on his/her own behalf and, if signing on behalf of a minor participant, is the parent or legal guardian of the minor participant and has full authority to give a valid release on behalf of such minor. **ALSO, THE UNDERSIGNED HEREBY REPRESENTS AND WARRANTS TO PCCC THAT THE PARTICIPANT'S PARTICIPATION IN THIS EVENT IS ENTIRELY VOLUNTARY AND IS NOT REQUIRED BY THE SCHOOL OR FOR ANY CLASS OR COURSE IN WHICH THE ATTENDEE MAY BE INVOLVED, OR BY ANY OTHER GROUP SPONSORING THE CONFERENCE OR PROGRAM.**

Living By The Rules

Our goal is to provide a safe Christian environment for all campers. Below is a list of rules that we must enforce to protect our campers and maintain our high standards. Parents - please review these rules with your child. Parents and campers should sign below, indicating the camper's commitment to live by these rules while at Mt. Palomar Bible Camp.

1. Males may not enter female cabins and females may not enter male cabins.
2. Campers may not leave their cabins earlier than 7:30 A.M.
3. Absolutely no lighters, matches, or any other fire-producing devices will be permitted at camp.
4. You may not reassign other campers to others beds or dorm rooms. Other campers' possessions, including bedding, are completely off limits.
5. You may not leave the camp for any reason without the expressed permission of the Camp Director. This includes for hikes that are not organized by staff.
6. All campers must attend all organized activities.
7. Displays of affection beyond handholding will not be permitted.
8. Swimsuits may not be worn other than to, from and in the swimming pool. Campers must cover-up while walking to and from the pool area.
9. Modest clothes are required. Shorts should fall on the lower half of your thighs. Bare midriffs are unacceptable. To prevent undergarments from being exposed, tank top straps should be 1.5 inches wide and pants must be secured around the waist or hips. Camp staff reserves the right to request that campers promptly change their clothes if campers are not dressed modestly. Please see the "Dress Standards" letter in the information packet for more details.
10. Electronic devices including radios, CD players, Ipods, Game Boys, laptops, etc. are not allowed.
11. Tobacco, drug or alcohol use will not be tolerated and will require the camper be sent home.
12. No knives (including pocket knives) or weapons of any kind are allowed. Violation will mean the camper may be sent home.
13. If staff must speak with a camper multiple times about behavior that is not in line with camp standards and/or is a disruption to camp, that camper can be sent home at the discretion of the Camp Director(s).

I agree to behave in a manner that is both respectful of Mt. Palomar Bible Camp staff and campers, as well as the Palomar Christian Conference Center staff and facilities. I will comply with the rules of Mt. Palomar Bible Camp as outlined above. I understand that violation of these rules may result in disciplinary action, including the possibility of being sent home.

IMPORTANT NOTE: If a camper must be sent home, the parents agree to come and pick him/her up without a refund.
